Reference to: The Trial of Political Dissident Ernst Zündel and the German Judicial System

Gentlemen:

There is a lot of talk around the world today concerning "Human Rights". Some countries are being accused of having no "Human Rights" and, others of violating "Human Rights" in one way or another. Nevertheless, it appears as if the "European Commission of Human Rights" only works on a selective basis, targeting this or that country.

Therefore, one cannot help believing that the European Commission of Human Rights is an instrument of the "International Dictator-Democracies" interfering with the internal affairs of nations who are not willing to go along with the victors of WW II. However, when real violations of human rights occur the European Commission of Human Rights cannot be found to carry out its intended purpose. Some of the most blatant violations of human rights occur in the "GFR" (German Federal Republic). In other words, any proof that the alleged holocaust *did not happen in the style, manner and scale* as propagated by the victors of WW II throughout the world, since 1940, is not permitted in any German court. Consequently, *the right to counter argue and to exonerate oneself is forbidden in German courts through "judicial notice"*. Has the European Commission of Human Rights ever encountered a more brazen violation of basic "Human Rights"?

The terror paragraphs #185 & 192 in the "special section" of the German Penal Code and the inhuman "judicial notice" *need to be examined by you*. Here the political/financial con-artists of an international caliber find shelter for their lies by being "insulted by the truth". The fraudulent claims of World Zionism to have lost 6 Millions of their brothers at the hand of the Germans through the use of lethal gas chambers is outright ludicrous and creates discord and racial hatred amongst people of good will. A case in point is the case of Ernst Zündel, which is presently before the courts in Munich, W. Germany, File No. 451 Cs 112 JS 3326/90. The case will be heard on 5. The European Commission of Human Rights has up to now always covered their eyes when German- not *East German* -West German, Human Rights violations were mentioned. What West Germany conducts in its courts are *political trials, of political dissidents*, under the guise of "criminal law"! We urge you to send an observer to the ZÜNDEL TRIAL, so you can see for yourself what's what!

Gentlemen, I hope that the European Commission of Human Rights can look into the matter and compel the German Courts to permit open discussions of the holocaust and any other topic of history without the German State judicial system's tyrannical interference. If the courts are to be used to decide matters of history- then let the accused persons present at least their findings, witnesses and documents(which is not now, and has not been the case in West-German courts). In Germany, internationally known historians are routinely disallowed as Expert Witnesses, men whose testimony was accepted at length in Canadian Court Cases in Canada, these same witnesses were qualified by the courts as Experts in their field. and were allowed to put documents, scientific reports etc., before the court. They were cross-examined by prosecutors and Judges in the ZÜNDEL CASE.

The same accused, in this Munich case, Mr. Zündel, who still resides in Canada, is being denied the expertise of these same witnesses by despotic, politically motivated and biased, German Judges!

The trouble with war-crimes trial

The verdict is in. Retired diplomat and accused war criminal, Imre Finta, has been acquitted of charges of kidnapping, forcible confinement, robbery and manslaughter that are part of events in Hungary in 1944. At the time, Finta, who now lives in Toronto, was a captain in the Royal Hungarian Gendarmerie, the force assigned to round up and organize the deportation of Jews from the city of Szeged. Now that he has been acquitted, I wonder how will those Canadian schoolchildren who attended the trial as part of their history course. How will their teachers explain the reaction of the Canadian Jewish community to the decision of 12 jurors good and true? Will they tell the Jews made a mistake in calling Finta a neo-Nazi? Somehow, I don't think so.

"It really makes us lose faith in the justice system of Canada," said Helen Spivak, chairman of the Canadian Holocaust Remembrance Association, as she heard the verdict at the Canadian Jewish Congress dinner in Toronto. "I'd expect," Sol Littman of the Canadian branch of the Simon Wiesenthal Centre, who was also disappointed but "not deterred." Howard Brith, English director of communications for the British, worried that the verdict might encourage anti-Semitic groups.

What is one to make of this response? Suppose we must all grit our teeth and remember that the people who make those sorts of remarks have suffered grievous personal losses at the hands of the Nazis. All the while, speaking as a Jew, I can't help feeling a profound sense of shame at such comments. Are those Jewish leaders not content yet? Virtually single-handedly, they have created the awful situation we now face because this trial took place: Jews feel the acquittal is a personal slap in the face, while, at the same time, Canada's teeny group of neo-Nazis are having a celebration. Tell me, who has gained? And who would have gained if the verdict had gone the other way and Imre Finta had been convicted on flimsy evidence of charges that should never

be made from outside. The law in its wisdom was deemed not to have jurisdiction over crimes committed in far-flung geographical regions. We realized, for example, that it would be almost impossible in a Toronto court room in 1990 to truly understand the small-scale but vicious persecution in the Third Reich and to grasp the nature of terror and the instinct to survive under such a regime during war. It does not mean, incidentally, that we should not prosecute people who have committed war and civil crimes simply because they are long ago and far away. You can't have a question of principle in dragging a Josef Mengele, the notorious "Angel of Death," to court. His crimes supersede all questions of time and place. In such a case, the question of whether the evidence is available is not the problem with the Finta case. It is the problem with the Finta case in order to prosecute them as the key elements in the charges simply cannot be produced. Where are the bodies of the manslaughter victims? Where is the property that was stolen? Who can be cross-examined in order to convict a Finta, many of the best witnesses have had dear in our system of justice must be suspended.

That is what should be worrying Brian Brith, not the notion that Finta's acquittal will encourage anti-Semitism. Those people who still do not believe the awful bloodstained reality of the Holocaust will never accept it. If Finta had been convicted, they would simply have seen him as a martyr to the Jewish conspiracy. I'm sorry, but neo-Nazis share my dislike of neo-Nazi crimes trials, but I reserve the right to disagree with them for my own sound moral and political reasons, quite different from those of the extremists on the right.

DRESDEN BOMBING — WORST MASSACRE IN HISTORY*

The nationally known magazine *Esquire* (65 E. South Water St., Chicago 1, Ill.) for November, 1963, carried the best article so far to appear on the Allied air war on civilians, "Apocalypse at Dresden." R. H. S. Crossman,** an Englishman, sub-titles his essay, "The long suppressed story of the worst massacre in the history of the world." He writes:

"The decastation of Dresden in February, 1945, was one of those crimes against humanity whose authors would have been arraigned at Nuremberg if that Court had not been perverted..."

When, because the Red Army was approaching only 60 miles away, a million refugees had swollen the population of Dresden, a totally non-military art city and hospital center, to 1,250,000, British and American bombers loosed three waves bomb attacks within twelve hours and followed up with Mustang divers to snipe off any fleeing survivors. Out of 23,410 houses in the

inner city, they left 24,866 destroyed, eleven square miles devastated, 35,000 recognizable corpses, and an estimated 100,000 unrecognizable ones! By contrast, Hiroshima's atom casualties were 71,579.

WOMEN AND CHILDREN MASSACRED TO IMPRESS STALIN!

How did this Allied mass atrocity come to be perpetrated? Because Churchill wanted "a thunderclap of Anglo-American aerial annihilation so frightful" as to impress Stalin on the eve of the Yalta Conference! On January 23, 1945, the order to wipe out Dresden was given, and the night designated for it was February 13, when on Shrove Tuesday a maximum of children in Carnival garb might be expected about! So at 10:09, while "gangs of little girls (were) wandering about in fancy dress," the British for 24 minutes created a fire storm over the city, ripping off roofs, sucking oxygen out of air-raid shelters, converting the inner city "into a sea of flames."

When by 1:22 some 10,000 wretched survivors had crowded into the Grosse Garten, the second wave of bombers deliberately directed their terror on this garden, and on the hospitals. "Of its nineteen hospitals, sixteen were badly damaged and three, including the main maternity clinic, totally destroyed." Heroic nurses managed to drag "thousands of crippled survivors . . . to the banks of the River Elbe, where they were laid in rows on the grass to await daylight."

THE CLIMAX OF BARBARISM — SNIPING DOWN WOUNDED CIVILIANS

But the Anglo-American "re-educators" of Germany had not sadism enough yet. At 11:30, 211 American Flying Fortresses blasted what was left of the city and parks so that for five days and nights the city burned. Yet even this third all-out massacre did not content the Churchill-Roosevelt-Morgenthau sadists. So that if possible not one single woman or child might drag itself to safety, they sent in:

" . . . scores of Mustang fighters diving low over the bodies huddled on the banks of the Elbe, as well as on the larger lawns of the 'Grosse Garten; in order to shoot them up. Other Mustangs chose as their targets the

Auschwitz deaths cut to 1.1 million

WARSAW — Plaques have been removed at the Auschwitz-Birkenau death camp memorial that inflated the total number of victims while understating the preponderance of Jews, the daily *Gazeta Wyborcza* says.

It said the plaques were taken down in line with findings by the Auschwitz State Museum that the number of victims in the two camps in southern Poland actually was 1.1 million to 1.5 million. Of that number, at least 960,000 were Jews, the museum concluded.

Previously, plaques in front of the International Monument to Victims of Fascism spoke of four million victims. Poles, not Jews, were listed first among the victimized peoples.

An estimated six million Jews were systematically murdered in the Nazi-led genocide of the Second World War. The largest death camps were located in occupied Poland, including Auschwitz-Birkenau, Treblinka and Majdanek.

The figure widely used in Poland of four million victims at Auschwitz-Birkenau was arrived at by a Soviet commission that came to the camp in February 1945, one week after its liberation. It later submitted its find-

ings to the Nuremberg war crimes trials.

Of the four million, the number of Jewish victims was often put at 2.5 million in postwar publications, wrongly suggesting that the Nazis had killed more than one million non-Jews there.

However, based on the numbering of inmates, letters linked to transports and statistical lists made in Jewish ghettos, the number of victims that can be documented is 1.1 million, about 90 per cent of whom were Jewish, said Franciszek Piper, head of the Auschwitz State Museum's history department, in an interview with *Gazeta Wyborcza*.

Piper said the true number likely was higher because of a lack of documentation of some victims. However, he said, the total probably did not exceed 1.5 million.

In addition to the 960,000 Jews exterminated, Piper estimates the victims included 70,000-75,000 Poles, 21,000 gypsies and 15,000 Soviet prisoners of war, and the rest of other nationalities.

Poland has pressed the Soviets since the 1970s to grant historians access to the Second World War camp records, which were packed up and taken to the Soviet Union soon after the liberation, Piper said.
