Article 2. — The organization of the Committees of Action for Nordic Co-operation will include all those who feel


Article 4. — The Com-

the various races and nations
towards the progress of the
world, and consequently,
while realizing how nobly
the people of Nordic the Nordic
race have contributed to
the development of the world,
and ~~while~~ believing in
the further divine and
historical mission of the
Northern peoples, they con-
demn ~~any~~ over-estimation
of one's own and dis-
paragement of other racial
virtues and what is com-
mon to humanity.

Article 5. — The Committee
intend to afford the practical
means of reunion, coordination
and collaboration among
all those in every country
who are willing to work
together to ~~promote~~ ^{for the} ~~towards~~
promotion of cultural, economic
and political understanding
between the Nordic peoples
all over the world.

The aims announced will be
broadly achieved by means of
newspapers, books, pamphlets,
lectures, and all other kinds
of publications.







* All changes in the constitutions of the Union will require the approval of a two-thirds majority of the Governing Council.

Chapter ...

The Committees of Action

* ~~Article~~.. The Union will work by Committees of Action established first in the ~~greater towns~~, but later if possible throughout the ~~lesser~~ ^{municipal} provincial centres, ~~and throughout the countryside~~

* The ~~committees~~ will be governed when possible, ~~local centres~~ ~~branches~~ of the same Committees, ~~or~~ cells or sections, can

be constituted in various centres and throughout the countryside.

* The committees will be governed by a President, a Secretary who acts as Vice-president, and a ~~central~~

x The President
~~and the Secretary~~ will
be designated by the
acclamation of the Com-

* The Council
will act as a general
advising body for
the Presidents, who
have the power of fil-
ling up vacancies in
it from time to time.

All ex-presidents
should be members of
the Council, as men
whose service and ex-
perience best entitle
them to advise their
successors.

fication of the General
Representative of the

in a General Council at
which they will be re-
presented by their presidents.

Chapter . . .

The General Representative.

* A General Representative will be appointed for each nation by the ^{Executive} ~~Executive~~ Council.

* The General Representatives, while maintaining the indispensable continuous and direct liaison with central headquarters, will co-ordinate the entire work of their Committees in harmony with the supreme aim of the Union in such a way that their activity can be ~~developed~~ developed in full accord with the laws of their respective ~~countries~~ governments, the traditions of their respective countries, the character

of the inhabitants and the particular position of their countries.

For this reason the necessary autonomy is allowed to the General Representative ~~as~~ and the Committees as well as an efficient independence, so that from the particular and free contribution of every people belonging to the Nordic race, the harmony and unity of the its high mission can be effectively realised.

x The General Representative organises a Secretariate General in order to ensure under his personal responsibility the ~~working of the~~ necessary efficiency in the working of the organisation.

x In case of the

Temporary absence or impediment of the General Representative, provided it does not exceed the period of six months, he will entrust the carrying on of his ordinary functions to a member of the General Council or to the Secretary General.

If the impediment or the absence of the General Representative is prolonged over six months, the Central Council will decide whether a new representative must be appointed.

x The General Representative will constitute committees and appoint or ratify their presidents and councils.

He can also dis-
band councils, ^{dissolve} suppress
committees and revoke

the appointments of Presidents. In similar cases he will notify the General Council at its first meeting after the action taken.

x The General Representative, either on his own initiative or at the request of the General Council can also appoint special Commissions for determined activities. They will be autonomous as regards their functions although always under the general co-ordination of the General Representative.

Chapter . . .

The General Councils.

Exceptionally the General Representative can summon to form part of the General Council ~~members~~ ~~of the committees~~ prominent members of the committees in the country who, although not being presidents, will by their capacity and experience contribute ~~in an~~ ^{considerable} effective manner to make the General Council into ~~an~~ ^{so} ~~highly~~ effective assembly ~~and the highest expression of the organization of the committees of nations in the respective nations.~~

x The General Council can be

x The presidents of all the committees in a ~~nation~~ each nation constitute the General Council. ~~which can be~~ convoked at any locality in every time it is deemed opportune by the General Representative, and in any case once a year.

The General Council can request the President to have it convoked, provided a similar request is made by a majority of its members.

x The General Council constitutes the highest expression of the organization of the committees in each country, whose advice the General Representative is ~~consulted~~ ^{will}

to ask in ~~any~~ important questions, though he is not compelled to take it, or even morally obliged to do so.

* The General Council will choose a Central Committee to represent the Council between its annual meetings and composed of a variable number of members but not exceeding twenty in all.

* The Central Committee will be convoked by the ~~the~~ General Representative at least once in every two months.

Ends and Means

* [The general aim of the Union shall be:

Peace between ^{all} ~~each~~ Nations and within each Nation, ^{founded} ~~based~~ on Order and Justice.
